### Sustainability at Boozt

#### Care-For Strategy

Our vision is to use our local Nordic position and our technology platforms to make sustainable choices easy for our customers and our partners.

Our *Care-For* strategy is our roadmap to becoming the leading responsible e-commerce company in the Nordics by 2025.

By 2022, we aim at reaching a 25% share of sustainable apparel products across our overall product assortment.

#### Made with Care Assortment

Our *Made with Care* assortment combines all styles that meet the sustainability criteria listed in the full document.

This category represents a genuine systemic change in production patterns that educates the customer about the socio-environmental impact of textile's production and consumption.

Therefore to ensure a reliable, transparent, traceable and genuine assortment, we rely intensely on globally recognized certifications, as well as extensive data collection.

### Textile criteria overview

For AW22, we accept products in the *Made with Care* category when:

### Environmental criteria

Products made from at least 50% material composition from more responsible origins will be eligible for the Made with Care category.

A "Best in Class" certification indicates that the certifications looks at Social aspects (S), is verified (V) by a third party audit and is traceable (T) using a chain of custody.

- A "Currently Sufficient" certification indicates that the certifications looks at Social aspects (S), is verified (V) by a third party audit or is traceable (T) using a chain of custody. Recycled materials are considered "Currently sufficient", as recycling is considered being in the middle of the waste hierarchy.
- A "Banned" material indicates that Boozt has decided to not buy this material for ethical, social and/or environmental reasons. Banned materials are regulated through internal policies that all suppliers need to comply to.

### Social criteria

Paired with the previous environmental criterias that apply on a product and brand level, the following social criterias, need to be respected in order to have a product in the *Made with Care* category.

The social requirements **focus on the risk classification of the manufacturing country**, whether it is considered a risk or low risk country. For each risk category, a list of country is presented, as well as the necessary certifications and practices.



It is important for us to ensure that garment makers throughout the supply chain have the following rights and treatments (*this list* contains the core labour rights, identified in amfori BSCI Code of Conduct, drawing on ILO, UN and OECD standards):

- The right of freedom of association
- Fair remuneration
- Occupational health and safety (OHS)
- Special Protection for young workers
- No bonded labor
- Ethical business behavior
- No Discrimination
- Decent working hours
- No Child labour
- No precarious employment

To best identify the need for external auditing and the requirements needed, we have decided to follow amfori BSCI "Countries Risk Classification" that rely on the Worldwide Governance Indicators, by the World Bank.

### Social criteria

The following table is a summary of the social certifications mentioned in the sections above that we classify as sustainable. Please note that the classification is Boozt's own interpretation, aligning with our own *Care-For* strategy and vision.

### Chemical criteria

To ensure that every product in the *Made with Care* category is processed in a **respectful way towards the environment and the workers, while also ensuring customer health and safety**, Boozt requires products to be certified by third party certification and/or to follow specific regulations.
